READ THIS DOCUMENT CAREFULLY, IT MAY AFFECT YOUR RIGHTS

By signing this agreement, you agree to the following terms and conditions:

*1. By signing this agreement, you are agreeing that we are permissive drivers of said vehicle and as such, your insurance carrier is the primary insurer should there be any loss or damage involving this vehicle.

2. You agree NOT TO DISCLOSE THE IDENTITY OF PARAMOUNT INVESTIGATIONS as the agent used to recover the vehicle to anyone unless compelled to by legal process.

3. You understand that Paramount Investigations does not report the recovery of said vehicle to the police department because it does not fall under the collateral recovery act. Paramount Investigation is simply taking possession of the vehicle with the written permission from the registered owner, exercising their right to take back their own vehicle.

4. All personal effects that are contained in the vehicle are your responsibility to return said property to the rightful owner. You understand that Paramount Investigations does not assume any liability with regards to vehicle contents.
